Sub: Intimation with respect to the Second Interim Distribution of the Company

This is to inform you that pursuant to the Hon'ble NCLAT's Order dated May 31, 2022, the Second Interim Distribution of the Company has been recently implemented for the eligible secured debenture holders.

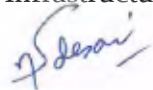
In view of the same, as per the second interim distribution calculations already carried out by Grant Thornton (the Claim Management Agency) basis the Revised Distribution Formula / Framework approved by the Hon'ble NCLAT vide Order dated March 12, 2020, the distributable funds under this interim distribution aside from secured lenders, has also been distributed to the eligible secured debenture holders, subject to certain claw back conditions prescribed per the NCLAT Order dated May 31, 2022. Such distribution to the eligible secured debenture holders in this round would in toto amount to 12.71% of the total admitted claim of the respective eligible secured debenture holders out of which 3.32% was distributed as Cash and 8.36% was distributed as InvIT units and the balance 1.03% represent InvIT units held back the then due to document deficiency. The held back InvIT units would be distributed in due course based on receipt of applicable documents. Consequent to this interim distribution, the admitted claim value of NCDs shall be reduced to the extent of the payout.

The list of series wise secured debentures eligible for this interim distribution is annexed herewith for your information and record.
